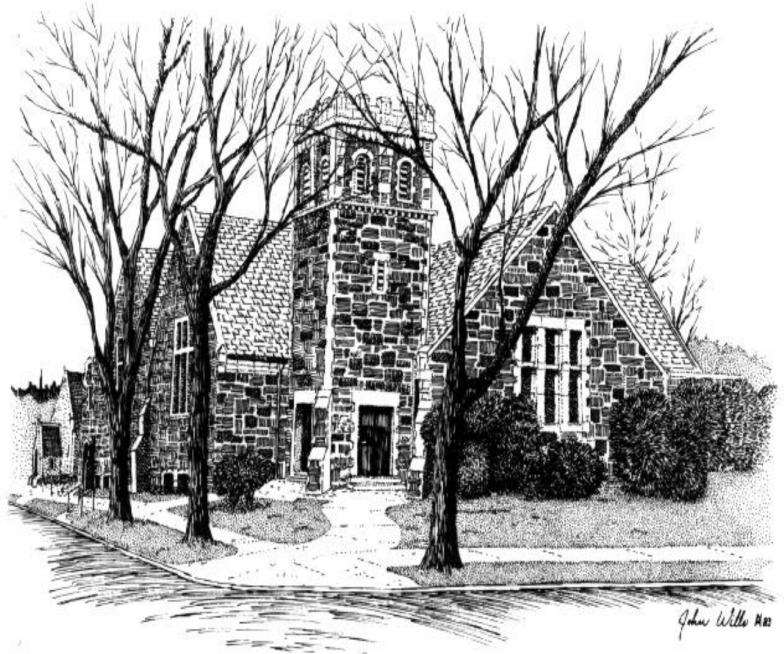

SENIOR MINISTER'S REPORT

Beloved,

2021 was a spectacularly complicated year. It was a year in our broader culture in which optimism and strife openly battled with one another. Is the pandemic getting better or worse? Will American politics and policies get better or worse? Is the economy getting better, or is it getting worse? We've been bounced between hope and resentment, good days and bad, new routines, old routines, and new-new routines. We've survived these ups and downs together. And as a church, we can be proud that we made appropriately cautious but necessarily steady progress together through a year of recovery that brought both challenges and joys.

Remember, at the beginning of 2021, we were still only worshiping virtually. But in February we had five new members join the church. It was a good mix of folks. Two were a couple who had started coming to church many months before COVID hit and had just never gotten around to joining. Two were a couple way out in California, one of whom had a childhood connection to the church, who started attending virtually after COVID hit. And one was a local who got connected to the church virtually after the pandemic hit. Five new members almost a year into a pandemic isn't bad at all for a church of our size, and it demonstrates that (though it wasn't easy) in 2021 we managed to build and sustain new relationships and make church work as best we could for many folks.

The rollout of vaccines occupied a lot of our attention in 2021. As a church we have decided thus far not to make a formal tally or enforce vaccination requirements, but, informally, the vast majority of us became fully vaccinated sometime last year. The vaccines have provided us all with more peace of mind, greater freedom, and no doubt they have helped to save a few of our lives, for which we are deeply grateful.

The arrival of vaccines, plummeting COVID case numbers, and the end of the state's restrictions on indoor gathering limits in early summer helped us all feel ready to return to in-person worship. And so (after a lot of discussion, planning, and preparation) on Sunday, July 11—*after 68 Sundays of virtual-only worship*—we had what was probably the biggest turnout we've ever had for a worship service in July! As I preached in Advent 2021, Christians are a people of incarnation and embodiment: God showed up for us, in Jesus Christ, in the flesh. There's something essential about in-person worship to the way we build community and worship God together.

Successfully facing challenges as a community and successfully showing up for one another go handin-hand. That was part of the reason I reached out in partnership to our sister UCC church, Union Congregational Church, in Montclair, to put together the 2021 Confirmation program. As individuals we can't go it alone, and churches can't go it alone either. We need fellowship, we need cooperation, we need inspiration. So, this fall Rev. Katrina Forman and I joined forces and brought 17 8th graders together for a joint confirmation program shared between our two churches. The kids and the ministers are having a great time. I hope that this is the beginning of greater Christian love between our churches.

Looking forward into 2022, I believe the gains of 2021 will be built upon and that there is the possibility of getting more and more "back to normal." At some point in 2022 the pandemic will have receded enough (considering the protections we now have) that it will be possible for ALL of us to be back in the sanctuary together. It will be possible to take masks off and eat together in Robinson Hall and have

fellowship. It will be possible to pick back up where we left off in March 2020 with revitalizing our mission and our community. At some point in 2022 I think it's very likely that COVID-19 will no longer be the limiting factor. The limiting factor will be us. Will we be ready to break out of the pandemic mindset? Will we be ready to trust the protections we've gained since 2020? Will we be ready to get out of our jammies and head out the door for church in the morning to show up in the biggest way possible for our community? Will we be ready to risk a little exposure for a lot of love? That's up to us. And it will be a critical part of our work and conversation in this new year.

Music Ministry Highlights

- + **TECHNOLOGY** During the year I selected the camera angles for worship services as well as scheduling the livestreams on YouTube and Facebook. Our equipment is minimal. Having only one camera puts us at a disadvantage in having to watch the camera zipping and zooming during the service. If livestreaming from the sanctuary is to continue, it's vital that we make the investment in good sound and video equipment that's procured and installed in a carefully planned, systematic way. The worship of our Creator deserves no less. The Ministry of Worship will be looking into this.
- + CHANCEL CHOIR our adult music leaders, whose care and dedication to their ministry is a superb example for our younger choristers. We are blessed with an exceptional adult choir! What an incredible joy to have our choir return to in-person ministry beginning on Celebration Sunday and continuing through Christmas Eve. They wear special masks designed specifically for singers to help let the sound out and keep the germs away. The Chancel Choir forms the core of the GLEN RIDGE CHORAL SOCIETY.
- + GLEN RIDGE CHORAL SOCIETY From January through May, the Choral Society rehearsed virtually each week. They recorded several pieces which were offered during the virtual Spring Concert. Rehearsing in person beginning in September, they presented the *Requiem* by John Rutter on All Saints' Sunday, and the *Welcome Christmas!* concert on December 12. They are truly amazing!
- + VIRTUAL CHOIR We mastered the technique of creating a virtual choir. Members rehearsed on Zoom then did lots of independent at home practice. They each made an audio recording of themselves singing their part of the anthem. An audio engineer mixed all those vocal parts and the accompaniment together. We then created the video during a Zoom session where we sang along to the mixed audio recording. Our engineer made sure it all matched, and voilà!

- + CARILLON BELLS our adult handbell choir provides a first-rate example of commitment and enthusiasm for our younger ringers. In January through May they rang in the Blue Room balconies, recording their offerings to be broadcast during our virtual service. They returned to the sanctuary in September through December. Thank you all!
- + CHILDREN'S/YOUTH CHOIRS Our children's choirs included *Joyful Noise* (ages 3-6), *Cherub Choir* (grades K-2), *Carol Choir* (grades 3-8), *Chapel Bells* (grades 3-8). Due to the pandemic our children met virtually each week, January through June, using the special choir curriculum, *Keep on Singing*, which featured songs, activity videos, fun pages and hymn studies. Choirs resumed in-person rehearsals in September.

NEW DIRECTOR – Thanks to Elizabeth Herr Taylor, who volunteered to direct our Cherub Choir, beginning in September. What a blessing!

CHAPEL BELLS met in person all year, strictly following all safety protocols. They were able to minister in person while worship was still virtual.

- + INSTRUMENTALISTS Thanks to all the instrumentalists from the congregation who so generously shared their talents with us: Andrew Dik, *trumpet*; Patti Gsell, *flute;* Jill Simmons, *piano, organ, cymbells;* Craig Wood, *flute;* What a blessing to have these talented musicians in our congregation!

We were also fortunate to have many guest instrumentalists enhance our music throughout the year.

- ORFFINATORS Our adult Orff ensemble presented special music in January. The Orff instruments are barred, pitched percussion instruments (glockenspiels, xylophones, metallophones developed by Carl Orff). Orffinators included: Karen Augis, Patti Gsell, Susan Hughes, Linda Kerr, Diane Schaming, Jill Simmons, Janet Spoerl, and Wynne Zalewski.
- + PANCAKE SUPPER The annual Shrove Tuesday Pancake Supper could not take place due to the Covid-19 pandemic.
- + PALM SUNDAY No grand processional this year, but we were thrilled to have guest tenor soloist, Theodore Chletsos, lead us into Holy Week.
- + MAUNDY THURSDAY Oboist, Meredyth Coleman, presented eight musical meditations with organ for the Tenebrae portion of the service.
- + EASTER Soloists Elizabeth Perryman and Diane Schaming shared the vocal leadership with their magnificent singing. Harpist, Karen Stern added a celestial sound to the service. The Chancel Choir and Choral Society presented a *virtual choir* anthem, and the Carillon Bells presented a virtual handbell anthem, all contributing to great resurrection joy!
- + MOTHER'S DAY MUSICAL No musical this year due to the pandemic.
- + CHILDREN & YOUTH SUNDAY June 13: Our children's choirs presented a *virtual choir* video of "We Are the Church." The Chapel Bells rang in person.

- + SUMMER MUSIC Special music was offered each Sunday during the summer months. With the livestreamed service and no choir, it was much like the previous months.
- + **RETURN TO IN-PERSON WORSHIP** While we were glad to be able to worship online when we had to, it was an enormous blessing to have congregants return in person, beginning July 11. It's important that we share in-person interaction, support, and love as a family of faith here in Glen Ridge.
- + CELEBRATION SUNDAY Sunday, September 12: It felt like Easter, with our Chancel Choir having been resurrected from Covid exile.
- + ALL SAINTS' SUNDAY October 31: The *Requiem* of John Rutter was presented by the Chancel Choir and Choral Society as the core of this worship service. Organ, flute, oboe, cello, harp and percussion accompanied the *Requiem* and service.
- + WELCOME CHRISTMAS! Concert and Carol Sing December 12: We required proof of vaccination and face coverings to gain admission this year. We had no idea what the attendance would be like. 229 audience members, 56 musicians, and one seeing-eye dog in training enjoyed an afternoon of very special holiday musical offerings by our Glen Ridge Choral Society, Carillon Bells, Children's Choir, harp, brass, percussion, piano, and organ.
- + **BELL SUNDAY** December 23. Always a spirit-filled service. Our two handbell choirs Carillon Bells, and Chapel Bells rang. Chancel Choir and children's choirs all sang. Amazing joy!
- + CHRISTMAS EVE We had one Festival Family Christmas Eve Service at 5pm, with music by the Chancel Choir, Children's Choirs, Chapel Bells, trumpet, organ and piano.
- + **BANNERS** Thanks to David Dik and John Dobbs for their continued supervision of the seasonal transition of the streamer banners that hang from the ceiling in the sanctuary.

The Bible uses creative language familiar to kids and features full-color, vibrant artwork. Church School attendance ranged from 10-28 children. MINISTRY OF CHILDREN AND YOUTH

The Ministry of Children and Youth (C&Y) oversees the faith formation, education, and activities for everyone ages 0-18. Despite the on-going pandemic, C&Y continued to provide programming *every single week,* holding nearly all of our usual events in one form or another.

We are grateful for all the children and youth and their families who participated in and supported the programs. And for the plethora of volunteers who helped make everything happen — from teaching Church School and leading groups to assembling Lenten packets and helping make crafts. We are blessed to have so many people invested in our children and youth!

FAITH FORMATION AND EDUCATION

Church School

Church School met weekly during the school year under the direction of Maira Hernandez-Kinloch. They met via Zoom during the winter, moved outside for the spring and early fall, and finally returned indoors to Robinson Hall late fall.

While Church School was on hiatus over the summer, children were invited to join their families for the worship service. Worship bags were provided for the children; these included a stuffie with Bible verse, Old and New Testament readings, games and puzzles that correlated with the lectionary readings, and coloring supplies.

Beginning in the fall, the Church School program changed and now offers Sunday morning classes for pre-k through 6th grade. Child care is available for those ages 3 and under.

Baptism

There were no baptisms this year.

3rd Grade Bibles:

C&Y presented Bibles to six 3rd graders. As part of the worship service, Pastor Jeff guided the recipients in their first use of their new Bibles.

Confirmation

After a year off due to a combined 7th/8th grade class in 2020, Confirmation resumed in the fall for those in 8th grade (and beyond). It is a new joint program with Union Congregational Church of Montclair. GRCC has nine Confirmands attending. Together they are exploring their "faith and worship traditions through field trips to multiple houses of worship (Christian and other faiths), by discerning how God is still speaking, with a spring retreat, and by planning a joint Confirmation worship service in May...[The] goals are to help participants explore their faith in the context of the diversity of faith traditions and expressions, connect with the divine in their own life and language, and recognize their own leadership within their congregation."

SERVICE, MISSION, AND OUTREACH

Family Faith

Led by Janet Spoerl, Family Faith continued to engage the UCC 3 Great Loves of Neighbor, Children, and Creation. Families practiced the Intentional Gather Pause Speak technique, participated in "Church Play Walk Talk" gatherings, celebrated Earth Day and learned about water, explored racial diversity and Juneteenth, spent the summer Flaneuring (walking leisurely to intentionally observe nature), and delved into studies of peace, justice, and indigenous peoples including a field trip to Montclair's Bonsal Preserve. Janet Spoerl also did itinerant visits to families upon request, both in person and via technology.

Playground Group

Led by Janet Spoerl and Meredith Busby, this Family Faith extension group met weekly in the spring for playtime, chatting, and exploration of environmental, diversity, and social justice topics.

CREW — Christians Ready Equipped and Willing — Youth Group grades 4-7

CREW met most weeks through May as a cross-over experience with their Church School class. In the spring, they held a snack collection event for the MEND food pantry, and two elder outreach projects: making palm crosses and Holy Week learning packets, and making May treat boxes and nosegays.

High School Fellowship Group

In the fall, Nadine Pappas-Wilkes invited high school students to participate in two service projects: cooking dinner for the We Got This (WGT) truck, and a shoe collection in conjunction with the Kiwanis Club. C&Y ran the GRCC portion of this Soles for Souls shoe collection, with a total of 468 pairs of shoes donated. High school students helped with a number of ministry activities throughout the year, including CREW projects, the grades 4-7 Church School classes late winter/spring, and the Advent Experience.

C&Y EVENTS AND ACTIVITIES

Church School Initiatives

C&Y supported Mrs. H-K with the "Spread the Love" peanut butter collection, the "God Loves You" neighborhood walk, Easter egg hunt on the South Lawn, and the Lantern Walk. C&Y also provided the supplies for the GRCC Market Thanksgiving dinner bags.

Lent

Bags for at-home engagement during the Lenten season were assembled in Robinson Hall and delivered to all GRCC families with children 0-18. Additional bags were delivered to church elders. Bags included purple items for Transfiguration Sunday, reflective readings, a booklet about Lent, Lenten activity packet and calendar, pancake mix and maple syrup for Shrove Tuesday, pretzels, multi-cultural crayons, song sheets, and a garbage bag for purging 40 items for donation. For Holy Week, Church School students received a "Holy Week Box" to use along with daily readings.

Children and Youth/ Senior Recognition Sunday

Several families returned to the sanctuary for this service. The children participated by reading portions of the scripture, and a couple of high school seniors offered their faith journey reflections. All graduating seniors were presented with Bibles.

Vacation Bible School

Due to Covid and construction, VBS was on hiatus for the third year. It will return in June 2022.

Celebration Sunday

C&Y provided lawn games and activities as well as playground supervision during the picnic.

Chili Cookoff

C&Y ran the children's activities at this event, including an inflatable soccer target, pumpkindecorating, face-painting, tattoos, and crafts.

Advent Experience

The Advent Experience fully returned this year. Outside were live animals at the stable, a dramatic performance of the Christmas story by Pastor Jeff and Tom Mustachio, and carols led by a quartet of choir members. Inside were cookie-decorating, crafts, ornament-making, and coloring. This event drew many people from both GRCC and the wider community.

PILGRIM PRESCHOOL DIRECTOR'S REPORT

Pilgrim follows an academic calendar so this report is divided into two parts: January-June 2021 and September-December 2021.

January 2021 - early March 2021

Pilgrim continues the "Outdoor School" model that we designed in September 2020. We still have four canopies for four 'pods'. January-early March finds us on Zoom and on the playground only. The children enjoyed weekly scheduled playground time and we all enjoyed these very snowy couple of months. Unfortunately, one of the canopies was destroyed by the heavy snow. Fortunately, some of the Child Care Grant Funds were available to replace the canopy.

March 2021 -June 2021

Pilgrim is overjoyed to have the teachers start the Covid-19 vaccination process. This allows the teachers to be safe and have the children enter the classrooms again after a year of absence from being inside. Pilgrim has an air purifier and a reverse window fan in each classroom.

Pilgrim is allowed to add more children to the enrollment due to new regulations. Pilgrim finally is stepping back to some degree of 'normal.' The children and families are thrilled to be together again.

Pilgrim ended the school year with the sweetly significant planting of a redbud tree for our beloved Officer Roberts (lost to Covid-19 in April 2020). Pastor Jeff officiated and blessed the tree. The children helped recite the "Little Tree" poem and urged our little tree to grow and be strong. Alice and Gavin Roberts attended and distributed their 'Community Heroes' coloring books to the children. Please stop by and read the plaque and see the tree on the lawn in front of the playground.

September 2021 -December 2021

Pilgrim Preschool begins year 65 looking much like a typical year should. Everyone is still masked since there isn't a vaccine for children under 5 years old yet. The canopies continue to serve us well.

Pilgrim has resumed Afternoon School and is enjoying nearly full enrollment.

Pilgrim was honored to assist the M.E.N.D Star Tree Project by sponsoring six families and their Christmas Wish Lists. Pilgrim also participated in the Soles4Souls donation effort.

The 2021 year ended with some difficulty due to the new Covid-19 variant, Omicron.

MINISTRY OF ADMINISTRATION, PROPERTY, AND PERSONNEL

Overview

This ministry maintains and improves the buildings and grounds of the church and manages the Operating and Building Maintenance Fund monies in support of this. AP&P provides general management support for our administrative and maintenance staff plus our vendors. We manage rentals and support special events.

2021 Highlights

- 1. Completed the Robinson Hall Handicap Access Project (Chairlift and ADA compliant bathroom).
- 2. Renovated another bathroom in back of Robinson Hall.
- 3. Negotiated and prepared for rental space for the Glen Ridge Historical Society and its Archive.
- 4. Updated heating system with a new boiler and related water pumping system plus heat valves.
- 5. Updated the Chapel with air conditioning per a request and funding from St Francis.
- 6. Initiated a marketing campaign to be continued and expanded in 2022.
- 7. Started upper façade repair to address water incursion accelerated by the hurricane. Sized and contracted for extensive repairs in the upper façade on the south side.
- 8. A transition to a new Office Administrator is taking place. We are proceeding with a Temp-to-Hire process to fill this position.
- 9. Octavio Morales acts as a lead Custodian as the Church and Pilgrim modify normal operations during this time of the COVID. He and our staff have worked diligently to help us through this challenging time.

Use of Funds

Our improvement projects are funded by the Building Maintenance Fund, which is in turn funded by our Endowment Fund. Special improvements requested by users of our space are generally funded by the requesting organization with our approval. Day-to-day operational support is funded by our Operating Fund, which comes largely from pledged contributions, rental revenue, and some fundraisers. We continue to balance providing services through employed staff and outsourced services as requirements demand. We are trying to insource services as much as possible so we can contain costs plus provide more steady employment for our staff.

Our Appreciation

AP&P thanks our staff and partners for all their support. Our Senior Custodian, Octavio Morales, Erika Morales, and Vernon Oliver have shown consistent performance and flexibility in supporting us. Octavio has applied his broad range of skills in building repair/improvement projects which helped us minimize outsourcing major projects like updating a bathroom, Historical Society space renovation, and north-side façade repairs/re-pointing.

We thank Alma Amendola for her support in the office for the last few years. Her warm, cheerful face to the congregation and community will be missed. We wish her well on her journey back to good health.

We thank Lesley Krien for helping us as a temporary Office Administrator. Her quick study of our requirements and proactive approach to the job was very helpful.

The many volunteers who helped cover the office were incredibly helpful in aiding the Church with this transition.

Mary Jones continues to help after hours to make our accounts payables and reporting run smoothly in support of Pam Figlar and her very effective, tireless Finance Ministry.

We work with many vendor partner organizations. Highlighting a few who helped us a great deal this year:

- Ken Dua Electricians Helped with Chapel AC and helped with heating emergency
- JW Pierson Heating and Cooling Chapel AC project

For Lent, Pastor Jeff read the Lenten Devotional "Lent of Liberation" by Cheri L. Mills and asked the Congregation to join him in reading it as well. WOMEN'S ASSOCIATION

The Women's Association is an organization of service and fellowship comprised of all the women of the Glen Ridge Congregational Church.

This past year was a unique and difficult year for the Women's Association just as it was for all of the church. However, we still tried to strengthen our church and contribute to the greater community.

Funding/Benevolences

We are best known for our two largest undertakings, the Rummage Sales and the Antiques Show. Due to the pandemic, we were unable to hold either of these events. As a result, we were unable to make any financial contributions to our local benevolences this year.

We did, however, continue our involvement with Kiva micro loans. Kiva is an international non-profit, the mission of which is to alleviate poverty through small loans to grow or start a business, go to school or access clean energy. As the loans are repaid, we reinvest in additional loans focusing on women with businesses in disadvantaged areas. During the past year we were able to make 34 new \$25 loans for farming/agriculture, grocery/retail, cafés, and sewing/tailoring in 8 different countries (Columbia, Ecuador, El Salvador, Guatemala, Honduras, Kenya, Nicaragua and the United States). Thank you to Fran Wong for the time and energy she spends researching the loans and her willingness to manage our involvement.

We supported the church with monetary contributions by purchasing 3 new canopies for outdoor use and providing the flowers on the altar for the Sunday the church reopened in July. With the reopening of the church, the Women's Association resumed paying 50% of the Sunday sexton's salary and providing funds for the cleaning of the kitchens.

Please see the Women's Association Treasurer's Report for a complete list of disbursements and expenditures.

Fellowship/Service

We gather in fellowship to relax and enjoy the company of one another as well as to donate our time in support of other church ministries.

In June we gathered on the South Lawn for a picnic and an afternoon of fellowship. It was wonderful to reconnect with others after many months of separation.

We initiated a new project this year knitting items for MEND. We were able to gather in person on two occasions to knit together and to provide instruction for those interested in learning. In December we delivered 21 blankets, 14 scarves and 58 hats to MEND to be distributed to those in need through their various pantries. We hope this will be an ongoing project for many years to come.

We were able to support the church by fulfilling requests made by other ministries. We sorted, organized and bagged clothing donations for Afghan refugees, provided desserts, combread and servers for the Chili Cookoff and assisted with the repast for Beverly Curtis.

The Cards of Concerns is an ongoing project spearheaded by Nancy Bigelow and Lynn Ritchkoff. A huge thank you to both of these ladies for faithfully writing notes each and every week.

I am appreciative of all the support I have received from the women of the church and want to thank Linda Kerr and Phyllis Connolly for serving as Treasurer and Secretary (respectively) of the Women's Association. I look forward to the coming year with hopes of regaining a sense of normalcy.

MINISTRY OF WORSHIP

This report is being written as we enter our 2nd year of services dedicated to reaching our congregation wherever they find themselves. After a few trial runs, on July 11th we held our first in-person worship service since closing our sanctuary doors in March of 2020. Great effort went into creating a true sanctuary for worship. Required masking and clearly detailed distancing protocols were in place. Ushers, under the leadership of Josh Konetzni, carefully attended to our in-person worshippers as they came together in prayer and praise.

Pastor Jeff and Minister of Music, Tom Mustachio, rose to this greater challenge and created moving, restorative, stimulating, challenging, comforting, joyous, hopeful, accessible, and memorable services that were able to reach both in-person and virtual congregants. They were assisted by a team of videographers ensuring that our services were available to all, regardless of access. It has become obvious as this year has played out that our "new normal" is this in-person/virtual model of hybrid worship and as such, a powerful way to increase accessibility to all our parishioners.

As Worship co-chairs, it has continued to be painfully obvious that the success and future of our church is dependent on our technology capabilities to not only meet the needs of our congregants but to extend our reach to an even wider community as well. Our ability to reach all our congregants in a safe manner has elevated technology to equal importance with our "brick and mortar" structure. Our "new normal" of hybrid worship demands a dedication and investment in the upgrading of our tech capabilities, expanding the ability to pre-record, archive, and reach ever increasing numbers of members and friends.

Though it would not appear to be a Worship Ministry concern, in essence everything at GRCC should connect back to worship since it is the main mission of the church. GRCC needs to professionalize its support of our technology infrastructure and in 2022 we again advocate for a dedicated technology support person to build capacity among the GRCC staff and as a permanent member of the GRCC outreach team. To this end, the church will need to invest in technology and equipment in the coming years to improve upon this outreach.

Worship would like to especially acknowledge and thank Tom Mustachio for his herculean effort to return our Chancel choir, Carillon bell choir, Carol choir, and Chapel bell choir to weekly worship services. He is dedicated to creating safe rehearsal protocols which include specially constructed "singer's masks" and safe distancing, a requirement which has been constantly evolving over the year, based on recommendations from the CDC as well as best practices from houses of worship across the country. He also continues to oversee the videography system including training of our volunteer videographers.

We would also like to thank Pastor Jeff, who has the unique challenge of preaching simultaneously to a live congregation and an invisible audience, finding the inspiration to keep it real and fresh each week, regardless of access. He has been able to bring inspiration and comfort to all of us during this continued time of loss, frustration, and uncertainty.

As we conclude our term as co-chairs, we would like to thank all those – ushers, greeters, videographers and lay leaders – who bring vibrancy and immediacy to our collective worship experience.

MUSIC COMMITTEE

A subcommittee of the Ministry of Worship, the Music Committee was created in 1983 to serve as a sounding board for the Minister of Music, to provide liaison between the congregation and the music program, and to receive input from other staff members and the congregation on matters involving the music program. Over the years, the work of the Committee has evolved to support and facilitate various aspects of our music program. (See Minister of Music Report)

Most of our concerts are presented under the auspices of the Glen Ridge Community Concerts Series, now in its thirty second season. We offer members of the community at large the opportunity to participate in concerts given by the Glen Ridge Choral Society, which is composed of the Chancel Choir plus other interested singers. The group typically numbers approximately 40, with 20 Chancel Choir members, and 20 members from the community and congregation.

The COVID-19 pandemic continued to have a huge impact on Glen Ridge Congregational Church and the music programs. Musical rehearsals, presentations and gatherings were conducted virtually through May of 2021. The church opened the building in July and hybrid services and concerts began. Vaccination was required for all adult musical participants. Physical distancing protocols were instituted as well as mandatory mask wearing. This allowed for congregants and musicians to return to the building for in-person activities. The choirs were delighted to return to rehearsals and music making in-person. Singers' masks were purchased and provided protection as well as making it a little easier to sing. All the pandemic protocols allowed for the musicians to rehearse in-person and present live music once again.

As always, the efforts of our exceptional Minister of Music, Tom Mustachio, guided us through uncharted territory. Tom continued to think outside of the box and develop new and creative ways to continue the music ministry at GRCC. Tom, thank you for all your contributions to the ministry of the Glen Ridge Congregational Church.

The Glen Ridge Community Concerts outreach program is self-supporting. The financial sponsorship by church and community members continues to provide essential financial support for the concert series. 2021 concerts presented:

- March 21 Bela Horvath, violin, Thomas Mustachio, piano This was a live streamed concert (Facebook Live and YouTube) and the artists presented works by Bach, Bartok, Mozart, Rachmaninoff, Suk and Tchaikovsky. This concert was offered free of charge.
- April 25 Spring Concert: *With Instruments and Organ* featured the virtual Glen Ridge Choral Society, Carillon Handbell Choir and a vocal quartet. The program featured an eclectic mix of musical selections, featuring music by Bach, Beethoven, Franck, Verdi, Leonard Cohen and others. This concert was also offered free of charge.
- October 17 *Great Viennese Masterworks* featured works of Beethoven and Schubert performed by Bela Horvath and Friends. We welcomed back an in-person audience.
- December 12 *Welcome Christmas!* The traditional annual Holiday Concert and Carol Sing returned in-person. This concert was also recorded and shared via Vimeo after the live event.

Other musical events for which the Music Committee provided assistance:

- Mardi Gras Pancake Supper *cancelled*
- October 31 All Saints' Sunday Rutter Requiem
- Community Holiday Sing-along –*cancelled*

Special efforts were made to offer additional virtual musical presentations free of charge in 2020, via Facebook Live and YouTube:

- May 25 The Euclid Quartet and Friends presented chamber works of Beethoven and Mendelssohn.
- August 17 *Sisterhood in Song*, presented by Diane Schaming, Lydia Beasley, Natanya Washer, Jill Simmons and Thomas Mustachio.

MINISTRY OF OUTREACH AND MISSION

What a year we have had!!! As the pandemic continued to rage around us, our community suffered and our church helped in amazing ways. Serving on the Ministry of Outreach and Mission was a blessing. We were able to extend our collective Christian hands to many people near and far. Here are the details.

Within the framework of our denomination, the United Church of Christ, we supported One Great Hour of Sharing, the Neighbors in Need campaign, Strengthen the Church efforts, the Christmas Fund, and maintained our commitment to Our Church's Wider Mission (OCWM). We budget annually for the OCWM donation of \$24,000 but all the other monies, totaling over \$8,700, were contributed by church members.

We continued our efforts to help the people of Haiti as they lived through more earthquakes, political upheaval, economic devastation and societal breakdowns. The Overture International organization has expanded the efforts of the ESPWA orphanage we worked with previously. Their efforts reach out to local communities in the southwest area of the country. We have been able to support mobile health clinics, food shortages, education needs, job training all within the framework of Overture. In total, we gave \$4,350 to help our friends in Haiti.

Our international involvement included assistance to incoming Afghan refugees who were sponsored by Church World Services (CWS). As our government scrambled to aid the people of Afghanistan and Iran, we tried to help people when they arrived in our area. Fran Wong was instrumental in organizing collections of clothing, furniture and household goods for these families. The Biddolph Room was filled with donations! Our Mission Ministry also contributed \$375 to provide "Welcome Kits" and an additional \$2,723 in financial support to CWS. We will continue to address the needs of refugees as they arrive on our shores. Watch the e-news for messages about how you can help.

Food insecurity had a huge impact on many of our local neighbors. Our Church donated continually to support food pantries in our area. Our major efforts helped MEND, Meeting Emergency Needs with Dignity, as they supported 20 Essex County food pantries. We also contribute to Toni's Kitchen and Human Needs Food Pantry. We donated \$1,000 to Star of Hope Ministries in Paterson for their Thanksgiving Boxes of Love program. A call came for reusable shopping bags and we cleaned our closets for these bags to help the pantries. Our ongoing canned food collection generated several trips to the Bloomfield Church on the Green pantry where we dropped off our food donations. Your financial gifts allowed us to contribute \$2,685 to our favorite pantries. We will continue to collect nonperishable goods for the pantries in our area. You can drop off in the church kitchen or the south porch of our building.

Star Tree donations were overwhelming this year. We have an extremely generous congregation. We collected over \$3,200 and provided gift cards and wrapped gifts to 27 people to help their families celebrate Christmas. Our members love to help others!

A new initiative this year was supporting Bloomfield College. We began trying to find "hands on" ways to assist students with snacks, interview clothing, and money. Our efforts became all financial as the school struggled with declining enrollment and fear of insolvency. We contributed \$1,000 this year. The student base of Bloomfield College is primarily black/brown students from Newark and surrounding towns. Our Ministry is strongly committed to continuing our help for these students and the school.

Our church continued its commitment to education by using money from the SCEEP Challenge Award Fund to help two individual students pursue their life goals. You may remember the SCEEP program where students from Newark were bussed to our church on a weekly schedule and members tutored them through their primary school years. We offered Scholarship support to our SCEEP students who continued their education beyond high school. This year two students received grants from us and they are impressive students! Kaytie Zumba, tutored by Lynne Palmer, received \$1,000 to continue studying at a technology school to become a phlebotomist (she will draw blood). Paula Marchena, mentored by Susan Hughes, received a total of \$7,300 throughout the year to continue an internship at Johns Hopkins in neurobiology. Both of these women deserve our applause and support. Contributions to the SCEEP Challenge Award Fund are still being accepted.

We contributed \$1,000 to Family Promise of Essex County, formerly Interfaith Hospitality Network, to assist homeless families in our area. Most families are housed in hotels because of Covid restrictions and a shortage of volunteer churches. New programs are being considered and we will participate as we're able. Again, e-news will keep you informed as we make plans.

Our monies also support the Minister's Discretionary Fund and this year we donated to the Ashenfelter Run supporting scholarship efforts in Glen Ridge.

As Christians we are called to feed the hungry and clothe the naked; as a congregation we follow God's path joyfully. Thank you for your continual support of our church and its mission efforts.

GARDEN OF MEMORY COMMITTEE

The flagstone patio in the Garden has 134 stones each of which covers a space. In each space there are 4 sections for a total of 536 sections. Each section holds 2 urns for a total capacity of 1072 urns. There are 316 persons interred. There are 54 spaces fully available, providing 216 sections capable of holding 532 urns. In addition, there are a number of spaces which are partially occupied or reserved. Over the past 20 years, the Garden of Memory has sold an average of 4 spaces per year, but the last four years have seen a down turn in sales. In 2018, 2 spaces were sold. In 2019 1 space was sold and no spaces were sold in 2020 or 2021.

The Committee attempts to make the Garden a peaceful, attractive and dignified part of the church grounds that compliments the total appearance of our facility while providing an inexpensive alternative to traditional burials. The price of a section, which will accommodate two urns, is \$400. At the time of an interment there is an administrative fee of \$175 which covers the costs of the urn, plaque, and the opening and closing of the section. Since its inception, the Garden of Memory has been entirely self-supporting.

There were three interments in the Garden of Memory in 2021:

- James English
- Jim Waters
- Beverly Curtis

Joanne Meeker and Tom Meeker have resigned as a member and supporter of the Committee, but Joanne has continued to fulfill the functions of the Administrative Officer until such time as a replacement can be named. Their work and effort on behalf of the Garden were always appreciated by the other Committee members and by those who have enjoyed the Garden as a quiet, peaceful space for prayer and introspection. They will be missed.

Because of the additional work required to maintain the Garden, the Committee, with the assistance of Cherry Provost, has retained a professional gardener for occasional consultation and assistance with maintenance.

The current members of the committee are Susan Hughes, Susan Krien, Jeff Mansfield, Cherry Provost, Jim Watson and Linda Woodbury.

GLEN RIDGE CONGREGATIONAL CHURCH ENDOWMENT FUND 2021 ANNUAL REPORT

The Endowment Fund (EF) of the Glen Ridge Congregational Church was established in 1984 with the goal of generating income to support the maintenance, repairs and capital needs of our Church. The Trustees are pleased to report the following EF highlights for 2021:

- \$150,000 of contributions in 2021 to the Building Maintenance Fund (BMF), including a \$50,000 special contribution to help complete the ADA improvement and bathroom renovation projects in the Lower Hall.
- Total contributions of \$300,000 for 2020-2021, including \$100,000 in special contributions for ADA.
- EF balance of \$2,484,092 (net of contributions and fees) at year-end 2021, showing a 9.8% increase, or \$221,952, over year-end 2020.
- \$100,000 in contribution commitment for 2022, equal to 2021, to be paid in installments through the year.
- Diversification into two new equity and bond funds, now composing about 22% of the portfolio.
- Use of EF contributions on a temporary basis to help cover the Church's rising insurance premium.

2021 Portfolio Profile

The EF Trustees and our investment manager, Neuberger Berman (NB), are committed to Investment Policy guidelines established in 2001. These include a portfolio weighting of 65% equities and 35% cash and fixed income products, with the latter tending to move contrary to and help offset expected equity market volatility. Furthermore, equity investments are diversified and in large, liquid, U.S.-based public companies with a market capitalization of over \$500 million. Fixed income investments are restricted to investment grade securities rated no lower than "A."

As of 12/31/2021, the EF is invested approximately 68% in equities, 26% in fixed income and 6% in cash. Capital appreciation in sectors such as High Tech has tended over time to push the portfolio to a higher equity concentration. We are managing that risk down somewhat, but also believe higher equity levels are appropriate given the EF's long-term investment perspective. We also note that some \$250,000 of the individual bonds matured in 2021 into a distinctly lower interest rate environment, so simply reinvesting proceeds in single bonds could have locked the EF into extremely low fixed income returns in the area of 1% or lower.

Given our guidelines and the rate environment, the EF Trustees undertook a shift in investment policy in 2022. The EF has historically invested only in individual stocks and bonds since 2001, while many new financial vehicles have since evolved, providing more and better diversified investment choices. Under NB's guidance we have instructed that a portion of assets rolling over or reinvested in the normal course be placed into diversified funds, specifically the NB Genesis Fund (small cap equities) and the NB Strategic Income Fund (diversified fixed income). Both funds have a long track record at NB and are for institutional investors. As of 12/31/21, we believe they provide some needed diversification and yield boost, while remaining in line with our conservative investment guidelines.

A specific breakdown of the portfolio as of 12/31/21 has been included at the end of the report.

2021 Fund Performance

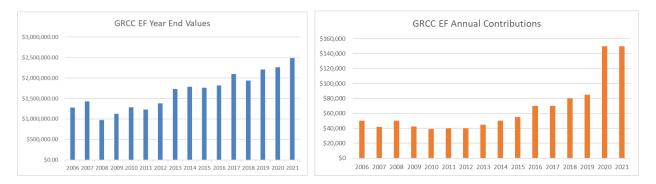
The overall portfolio performed markedly stronger in 2021 than in 2020 (already a strong year), primarily reflecting the impact of a robust economic rebound from COVID-19 and buoyant equity market response. For full-year 2021, the total portfolio return was 17.91% (net of fees) compared to the S&P 500 return of 28.71%. For the specific asset classes, equity returns underperformed the S&P 500 only slightly, with the EF showing a 26.99% return versus 28.71% for the latter. In contrast, fixed income was buffeted by inflation fears, tightening Fed fiscal policy and rising interest rates, with the EF showing a (- .28%) return, albeit better than the (-1.49%) decline for the Bloomberg/Barclays US INT Government and Credit Index.

Since we engaged NB as investment manager in 2001, the total portfolio has generated an annualized return (net of fees) of 7.54% versus the S&P return of 9.95%. Our equity portfolio continues to outperform the S&P (11.39% vs. 9.95%), while fixed income underperformed the Bloomberg Index (3.17% vs 3.75%). We continue to view bond market exposure as essential to help mitigate equity market risk and volatility, and for longer-term preservation of the EF corpus. While overall returns are still very acceptable, the Trustees continually evaluate our asset allocation and NB's performance to preserve and, where possible, increase returns appropriately.

Fund Balance and Distributions

As of 12/31/2021, the value of the EF was \$2,484,092.39, an increase of \$221,951.80, or 9.8%, compared to year-end 2020. This increase is net of the EF's 2021 normal and special contributions of \$150,000 to the Building Management Fund as well as associated fees, taxes and charges.

These charts provide details regarding the EF's growth and contributions to the Church since 2005. Since inception, the EF has contributed a cumulative \$1,296,500 to the Church, with \$835,000 since 2010, including the special contributions. This record underlines the importance of conservative investment and distribution strategies to maintaining a strong and growing Endowment.



Historically, the EF Trustees have targeted a contribution payout range of 3.00% - 4.00% of the EF's Net Asset Value (NAV), with annual payouts generally in the area of 3.5%, allowing for flexibility while preserving the corpus. However, in 2020 and 2021 we decided to increase normal distributions (4.4% of NAV in 2021), recognizing the Church's large projects and financial challenges, as well as

the benefits of a rising market. The special contributions to support the ADA Lower Hall Improvement Project further increased payouts on a one-off basis.

We are well beyond the original EF "distribution threshold" established in the by-laws but remain committed to the tenet, which prohibits distributions below a minimum EF balance of \$1,000,000 plus all additional gifts received beyond that level. The intent is for the Endowment to only distribute income and gains, leaving the principal intact for the Church's long-term financial strength.

Gifts and bequests are very important to the continued growth of the EF and have frequently been given as memorials. The Trustees appreciate these donations and ask the congregation to keep the Endowment in mind when making your short and longer-term giving plans.

A Funding Change and Comment on 2022

In early 2022, the Trustees agreed that EF contributions can be used, as determined by AP&P, to defray the Church's 2022 property insurance premiums. Traditionally, insurance premiums have been treated as operating costs outside the scope of the EF. GRCC's 2022 premium has increased some 26% to over \$66,000, and up by over 75% since 2015. This trend is onerous and taking place across the entire insurance industry. It is experience-based and not a result of the Church's own actions or claims submitted.

In consequence, the EF Trustees agreed to help pay a portion of the premiums related solely to the physical plant of the church building and parsonage. We view this as a temporary accommodation subject to annual review in conjunction with AP&P, taking into account premium trends and the Church's changing financial position and operating budget. This use of EF contributions could also constrain the Church's future capital projects.

We view the \$100,000 commitment for 2022 as appropriate based on the EF's recent performance and the Church's capital needs. In 2022, inflation fears, rising interest rates and volatile equity markets are creating a lot of uncertainty. The EF is currently carrying a higher cash balance of about \$150,000, a decision made late in 2021 to reduce equity exposure after a strong market rally and to provide for our 2022 liquidity needs in the face of that volatility. We note that future distributions could be reduced if lower market trends persist in 2022 and beyond. The EF remains focused on longer-term growth while still providing robust support for the Church's physical plant.

In closing, I would like to highlight the many years of service Alden Provost gave as Chair of the EF before stepping down in early 2021, and am grateful for all his transitional help, as well as for the support and informed insights of my fellow Board members throughout the year.

MINISTRY OF FINANCE

The Ministry of Finance is responsible for the financial operation of the Church to enable its ministry and mission. Responsibilities of the Finance Ministry include (1) overseeing the collection of all receipts and payment of all expenses, (2) managing the Church's investments that are not part of the Endowment Fund, (3) keeping detailed financial records, (4) preparing monthly financial reports, (5) issuing quarterly contribution statements, and (6) preparing annual budgets.

Financial Highlights of 2021

We started 2021 with the building closed due to the Covid pandemic. We assumed we would not be able to open for in-person worship or other events until September. However, we actually began in-person worship in July and slowly added other events, with a scaled back Chili Cook-off in October, a well-attended Requiem Sunday and a wonderful Welcome Christmas concert.

We really had no idea how this year would turn out with so many unexpected pandemic-related events, such as government mandates, vaccination boosters and an omicron surge late in the year. We are pleased to report that, in spite of it all, we had a surprisingly good year financially, ending with a deficit that was 23% lower than budgeted. Many thanks to those who were able to continue paying their pledges and, in some cases, a little more! And thanks to all for careful management of spending.

The highlights of the 2021 finances are further discussed in the Operating Fund section below. (Please see the Treasurer's Report on the pages immediately following this report for more details about the 2021 finances.)

• Operating Fund

Here is a summary of the actual Operating Fund activity for 2021 compared to the 2021 budget.

The Operating Fund closed the year ahead of budget. Although we were still in a deficit position, our deficit was less than the year-to-date budgeted deficit.

Receipts as a whole were ahead of budget, primarily due to more than expected income from Pilgrim and other building usage. Pledge payments and other support from the congregation were short by about \$13,300, but pledge payments alone were short by about \$28,500.

Expenses were actually slightly below budget, but the subsequent return of \$5,530 of unused C&Y offset to the designated fund increased the expenses and the deficit by that amount.

• Building Maintenance Fund

The Building Maintenance Fund received \$100,000 from the Endowment Fund in 2021 plus an additional \$50,000 to complete the accessibility project on the first floor of the Church School wing, including the new lift in Robinson Hall. The Ministry of AP&P took great care in managing the expenses while making sure needed repairs and upgrades were made to the buildings. The entire \$50,000 was spent for the accessibility project and \$63,440 was spent on other building repairs and improvements in 2021, with the rest being held over for large scale projects slated to be done in 2022 and future years.

• Paycheck Protection Program (PPP) Loan Forgiveness.

In May 2020, GRCC, including Pilgrim Preschool, was granted a loan in the amount of \$127,042 under the Paycheck Protection Program of the CARES Act. The primary purpose of the loan was to enable us to keep employees, such as Pilgrim teachers and choir section leaders, on the payroll during the coronavirus lockdown through June 2020, even if they were unable to actually do their jobs due to closures. In addition, we could use the loan proceeds to pay utility expenses. \$54,031 of the loan proceeds went to Pilgrim to cover their May and June 2020 payrolls.

In August 2021, we applied for forgiveness of about 90% of the loan, which was what we could substantiate for our applicable forgiveness period. In September 2021, we were granted forgiveness for \$117,141, which was the amount we had requested plus accrued interest on that amount. After that forgiveness, we had a remaining loan balance of \$9,901 for which we were required to begin making monthly repayments. We had made two payments, when, in December, our bank told us that the Small Business Administration had forgiven the balance of our loan. We subsequently received a refund of the two payment we had made.

The GRCC portion of the loan forgiveness was \$73,011, which is reflected in the Operating Fund balance at the end of 2021.

Budgets for the Year 2022

Although we came through 2021 in better shape financially than we expected, 2022 will be a challenge as the pandemic continues and uncertainty exists as to how and when it will wind down.

The full proposed 2022 budgets are presented on the last four pages at the back of this Annual Report. Here are the highlights:

• Operating Fund Budget

Finance had to wrestle with the issues of increased expenses and income expectations that are still falling below what is needed to run the operations of the church, as well as funding for existing and new programs as we attempt to resume our goal of growing the church. Although we are expecting modestly increased receipts for 2022, we were hit hard by some foreseen and unforeseen expenses. In the end there were two major events that helped us come up with this proposed budget.

- 1. The Endowment Trustees came through big time! Rising insurance costs in recent years (due to all the natural disasters that have been occurring) have become a burden on the Operating Fund budget. For 2022 there is a 26.12% increase over last year in the property/liability premium on top of a 19% increase the year before. This amounts to an increase of about \$20,000 for the last two years combined. The Endowment Fund Trustees have agreed to allow the portion of the insurance premium attributable to the property, or \$53,000 of the total \$66,260 premium, to be paid from the Building Maintenance Fund (BMF) thus removing this expense from the Operating Fund budget. There is adequate money in the BMF to cover this expense without jeopardizing the funding for needed building repairs and upgrades. The Trustees will review this agreement every year as needed.
- 2. The increase in the Operating Fund reserves. Due to a bequest, Paycheck Protection Program loan forgiveness and unrealized appreciation that has been continuing to increase each year in spite of all the mayhem caused by the pandemic, the Operating Fund balance at the beginning of 2022 is \$255,500. These operating reserves will allow us to cover a larger deficit within reason, however thus allowing the restoration of money to the Ministry of Outreach & Mission (MOM) budget and other increased expenses. We have not seen an Operating Fund balance over \$200,000 since 2013 and many of the intervening years were quite low.

Receipts: For the 2022 Operating Fund Budget, receipts totaling \$478,310 are based on \$395,000 in pledges and other support from the congregation plus \$83,310 from other sources such as arrears, offertory, church school, investment income, Pilgrim Preschool, St. Francis of Assisi and other building usage. This is an increase of \$39,950 from the 2021 budget. 70% of this increase is attributable to increased payments from Pilgrim Preschool due to their remarkable turnaround from the initial impact of the COVID pandemic, and to our new tenant the Glen Ridge Historical Society.

Disbursements: The 2022 Operating Fund Budget disbursements of \$546,970 is a \$58,710 increase from the 2021 Budget. Expenses in the 2021 budget were low because we had assumed the building would be closed most of the year, possibly reopening in September. Here are the major increases in budgeted expenses:

- Now that we have opened the building for in-person worship and other events, the budget for 2022 reflects the added expenses that will be need for increased sexton hours (\$26,720) and increased ministry programs (\$32,955).
- Our Parish Administrator salary expense increase includes \$24,000 to pay severance to Alma Amendola and agency fees for our search for Alma's replacement.
- A 5% increase in salary is included for the Professional staff, who have guided us safely through the last two years of the pandemic. This increase, along with a 5% increase in medical benefit premiums, added \$10,960 to the budget expenses.
- At the request of the Ministry of Outreach & Mission (MOM), we have restored \$10,000 to their budget so they will have money to support local charities. Last year the MOM budget was cut by \$10,000, resulting in the Local Benevolences portion of their budget being only \$900 in order to maintain their \$24,000 commitment to OCWM. Since there was \$6,900 left in the Local Benevolences Fund which was unspent from prior years, MOM had a total of \$7,800 to spend for local benevolences. That money has now all been spent.

Offsets from Designated Funds: Over the past several years, we have taken money from designated Special Purpose Funds to offset the expense of certain ministries. For 2022:

- There is no longer a \$10,000 offset to the Outreach & Mission (MOM) budget from the Memorials & Gifts Fund. Over the last three years we had pulled a total of \$30,000 from the Memorials & Gifts Fund for MOM and felt we could not take any more since the balance in that fund has been reduced to \$11,298 at the end of 2021.
- In 2021, the Ministry of Children &Youth (C&Y) expenses were considerably below budget as many activities did not take place due to the pandemic. C&Y only needed \$600 of the \$6,130 offset from designated funds. So, at the end of 2021, we moved the unused offset of \$5,530 back to the designated fund to be used for 2022.

Deficit: The Proposed 2022 Operating Fund Budget shows a deficit of \$68,660 for the year. Since the Operating Fund reserves have increased significantly, due to the receipt of a bequest, the PPP loan forgiveness and the continuing increase in unrealized appreciation, Finance feels we have sufficient reserves to cover this deficit. However, Finance and the Council will continue looking for additional sources of income.

• Building Maintenance Fund Budget

The proposed 2022 Building Maintenance Fund Budget reflects total receipts of \$100,000 derived solely from the contribution the Endowment Fund has agreed to make, which is the same amount they gave for 2021 (excluding their special contribution for the accessibility project last year). Thanks to the Endowment Fund Trustees for their generous contribution.

The Bottom Line

We expect 2022 to be another challenging year. We hope to continue getting back on track toward growing our income and with the goal of achieving a balanced budget as the Church rebuilds.

Operating Fund Reserves: We were fortunate that our Operating Fund reserves (our rainy-day funds used to cover cash shortfalls) ended 2021 with the largest balance we have had for a number of years.

Two of the events that made this possible are not expected to happen again. Although we are able to cover a larger deficit for 2022, we must spend wisely in the future and/or grow our income so as not to exhaust our reserves.

Spending Down Church Assets: For the last several years, we have been using some of the Special Purpose Funds to cover part of the expenses of some of our ministries. We have exhausted the logical fund choices. After this year, if we cannot grow our membership and income, we may be forced to explore making painful choices as a congregation.

What you can do to help: Thanks to everyone who helped make 2021 a better year than anticipated. It looks like we will once again have to climb out of a less than optimal financial situation. This year we did a lot of outreach to the local community to help those in need during this difficult time: We want to continue this outreach, but we need help to do so.

Each of us has the ability to help improve the Church's situation in some way. For those of us who can, fulfilling our pledges to the Church is a good start. If you haven't yet made a pledge for 2022, please do so. Or, if you have made a pledge, consider increasing it if you can. Sign up for recurring electronic pledge payments through your bank or Tithe.ly to help the Church better anticipate and control cash flow. Lastly, and most importantly, help spread the word of the Church's good deeds and mission throughout the community. Invite friends and family to join us for Sunday worship and other events.
